

SAFE DRIVING MEDIA CONTEST

PARTICIPATION CONSENT, COPYRIGHT ASSIGNMENT, AND RELEASE

I, the undersigned, am: eighteen (18) years of age or older and wish to participate in the Safe Driving Media Contest (the “**Participant**”) or the parent or legal guardian of the individual identified below, who is under eighteen (18) years of age and wishes to participate in the Safe Driving Media Contest (“**Minor**”) (*check one*).

I, as Participant or on behalf of the Minor (as applicable), consent to participation in the Safe Driving Media Contest (“**Contest**”), a contest in which participants submit video, radio commercial or media transcripts focused on driving safety, and for which cash or other prizes may be awarded to certain winners. I, as Participant or on behalf of the Minor (as applicable), understand that (a) the goal of the Contest is to have participants create content about driving safety, to be used, displayed and presented by the New Hampshire Teen Driver Program operated by the Injury Prevention Center at Dartmouth-Hitchcock, and (b) that the Materials (defined below) submitted in connection with the Contest will be used, displayed and presented as a resource that will provide teens with information about the risks of operating a vehicle and how to make safe and responsible choices.

I, as Participant or on behalf of the Minor (as applicable), agree to comply with all Contest rules. I acknowledge that these rules may change from time to time without notice to me. I, as Participant or on behalf of the Minor (as applicable), further understand that the deadline to submit a Contest entry is May 28th, 2021 at 11:59 p.m., but that this deadline may be extended by Dartmouth-Hitchcock without notice. If a Participant’s entry is submitted after the deadline, the entry will not be considered.

I, as Participant or on behalf of the Minor (as applicable), hereby irrevocably transfer, assign, and otherwise convey to Mary Hitchcock Memorial Hospital and Dartmouth-Hitchcock Clinic, its successors, licensees, and assigns (collectively, “**Dartmouth-Hitchcock**”) all ownership rights in and to any videotapes, photographs, motion pictures, written materials and/or information submitted by Participant/the Minor to the Safe Driving Media Contest (the “**Materials**”), including all copyrights and intellectual property rights in the Materials. I, as Participant or on behalf of the Minor (as applicable), irrevocably permit, authorize, grant, and license to Dartmouth-Hitchcock the right to use, display, publicly perform, exhibit, transmit, broadcast, reproduce, and otherwise exploit the Participant’s/Minor’s name, biographical information, recorded voice, video, likeness and/or performance, and the absolute and irrevocable right and permission to record, publish, broadcast, distribute, exhibit, reproduce, or otherwise use the Materials.

I, as Participant or on behalf of the Minor (as applicable), (a) acknowledge that I have no expectation of compensation or other remuneration hereunder or in connection with the Materials, and (b) waive any action that I may have for payment or royalties in connection with any exhibition, televising, or publication of the Materials.

I, as Participant or on behalf of the Minor (as applicable), acknowledge that the winner(s) of the Contest is (are) responsible for paying any taxes associated with receiving the cash prize. I further understand that Dartmouth-Hitchcock will provide the winner(s) of the Contest with a FORM 1099-MISC, and that the winner or the winner’s legal guardian (as applicable) is responsible for consulting with an accountant and making any tax filings that may be necessary as a result of receiving the cash prize.

By signing this Participation Consent, Copyright Assignment, and Release, I, as Participant or on behalf of the Minor (as applicable), release and forever discharge Dartmouth-Hitchcock, its subsidiaries and affiliates, and its officers, directors, trustees, employees, members, managers, agents and other representatives from all claims and demands arising out of or in connection with the Participant’s/Minor’s participation in the Contest and/or any use of the Materials, including, without limitation, all claims for invasion of privacy, infringement of my right of publicity, defamation, and any other personal and/or property rights.

I, as Participant or on behalf of the Minor (as applicable), have read and fully understand this this Participation Consent, Copyright Assignment and Release, and all my questions regarding this agreement have been answered. I further acknowledge that (a) the Contest and these rules are governed by New Hampshire law, (b) the Contest rules are subject to change at any time, and (c) that Dartmouth-Hitchcock has the right to cancel the Contest at any time prior to selecting a Contest winner.
